TJ has since retired from North Platte Fire Department and is currently the Clinical Director/Paramedic for Priority Medical Transport. - Demonstrate the use of general household supplies to make realistic trauma injuries.
- Discuss the use of realistic injuries to better prepare our students for the field.
- Demonstrate how to apply moulage to simulated patients, for a variety of injuries.

BIO:

Bob Hessler was an EMT/Firefighter for Scottsbluff Volunteer Fire Dept for 13 years and worked for Valley Ambulance for 12 years. He is the owner of Safetyline Consultants, Inc which is a safety training center for businesses, churches, schools, hospitals and nursing homes. He writes their safety/security plans and also does disaster/active shooter drills. Bob is also the coordinator for Scotts Bluff County CERT/SAR team. CERT is a program put on by FEMA to prepare people for disasters and SAR is a Search and Rescue team. This is where he taught himself moulage and making all his own products. He does all the moulaging for the trauma surgeons training in Scottsbluff and the moulaging for drills around the area.

So I'm The Training Officer, What Now? Karen Bowlin

At the end of the presentation attendees will;

SATURDAY: JANUARY 13, 2018

TRAUMA, Karen Bowlin

This Class meets NCCP on, CNS Injury, Hemmorage Control-Tourniquets, GCS Scores, Selective Spinal Immobilization.

At the end of this session the attendee will;

- Recognize the signs and symptoms of severe hemorrhage.
- Practive the application of a tourniquet.
- Identify the signs and symptoms of a patient with a central nervous system injury.
- Practice GCS scores on trauma patients.

CARDIAC, Ann Marie Baker

This class meets NCCP on, Stroke, Post-resuscitation care, Chest pain from cardiovascular causes, Cardiac arrest and ventricular assist devices.

At the end of the session, the student will be able to:

- Understand emergency care for the cardiac arrest patient.
- Understand assessment and treatment of patients with specialized cardiovascular needs.
- Understand acute coronary syndrome signs, symptoms and treatment.
- Understand medical conditions that may lead to cardiac emergencies.

OLD AGE IS NOT FOR WIMPS, Sandy Massey

- Explain normal physiology changes that occur with aging.
- Describe Changes you may need to make when assessing an elderly patient.
- Recognize and empathize with aging patients.
- Working with nursing home staff, family members or bystanders and distractions that may occur.
- Identify and understand current guidelines, assessment and treatment for the stroke patient.

The deadline for these awards is December 31st for presentation at Convention in March.

Leo J O'Brien, Jr. Award This award is presented for outstanding Achievements that an individual has attained or accomplished in the emergency medical field.
Hero Award This award is presented for outstanding actions of a person rendering aid to an individual in medical crisis that warrants the person being called a hero. This can also be presented to an EMS provider that goes above and beyond the call or duty. The following provider and instructor award nominations must be a current NEMSA Member.
NEMSA Emergency Medical Responder of the Year Award Awarded to the EMR who has demonstrated outstanding skills, training and services to their community and/or State of Nebraska.
NEMSA Emergency Medical Technician of the Year Award Awarded to the EMT who has demonstrated outstanding skills, training and services to their community and/or State of Nebraska.
NEMSA Advanced Provider of the Year Award Awarded to the Advanced Provider who has demonstrated outstanding skills, training and service to their community and/or State of Nebraska.
Chuck Woll Memorial NEMSA Instructor of the Year Award This award is given to the EMS Instructor who has made the greatest contribution to local or state EMS as an instructor The person must be a State of Nebraska licensed EMS Instructor providing education for EMR, EMT or Advanced Provider personnel.
The Hall of Fame Award will be chosen by a unanimous vote by the the NEMSA Board of Directors. Nebraska EMS Association Hall of Fame
Nominations may be submitted at any time during the calendar year. This in not an annual award and may be given to several recipients or not at all during the calendar year. An awardee does not have to be an actual provider or NEMSA Member. They can be a spouse, political figure, etc. One who has been a steadfast supporter of individual providers services or the profession as a whole. An awardee can be a provider of any level from an EMR to paramedic, nurse of physician. There is no year of service requirement. The individual must have made a significant impact on their individual service, statewide EMS or variety of services in their area or region. Some examples of this are direct patient care, quality assurance/improvement, training, professionalism, CISM, community awareness/education, legislation political action, medical direction. An awardee can be an individual who has made significant contributions to the education of EMS providers through time, dedication and the amount of involvement with classes, Hall of Fame award may be presented posthumously. Award will be presented at Nebraska EMS Conferences. The Hall of Fame Award will be chosen by a unanimous vote by the the NEMSA Board of Directors.


